Sub: No Objection Certificate (NOC) for importing Non-CITES Cage birds.

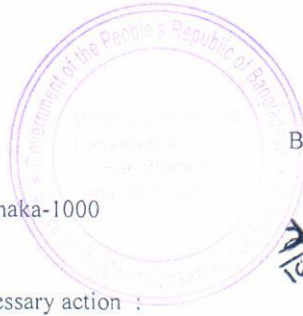
With reference to the above mentioned subject, the undersigned is directed to issue No Objection Certificate (NOC) to M/S. Feather World, Ka-32/A, Nadda, Gulshan, Dhaka for importing following Non-CITES cage birds from Maxio for commercial purpose.

7.	White throated Magpie jay	<i>Calocitta formosa</i>	20 (Twenty) heads
8.	Geelkoptroepiaal	<i>Xanthocephalus xanthocephalus</i>	20 (Twenty) heads

Conditions:

1. The above mentioned cage birds will have to import through Hazrat Shahjalal International Airport, Dhaka.
2. Imported birds must be kept in cages, so that they could not come in contact with any other animals.
3. Imported cage birds cannot be released in nature.
4. Dead birds must be buried deep in the ground.
5. After import, rings must be worn on the legs of imported birds within 7(seven) days and inform the licensing authority.
6. Importer will have to collect Quarantine Certificate from Livestock Quarantine Station, Hazrat Shahjalal International Airport, Dhaka.
7. This Permit is not transferable and import of wild bird is strictly prohibited.
8. Imported birds must be verified by a forest officer immediate after reach at Hazrat Shahjalal International Airport before leaving the Airport premises.
9. Validity period of the permit is up to 15 August, 2022.
