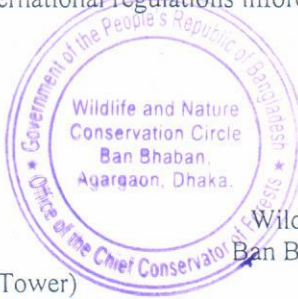
Sub: No Objection Certificate (NOC) for Exporting Non-CITES Cage birds.
