## Conditions:

- 1. The above mentioned pet birds will have to import through Hazrat Shahjalal International Airport, Dhaka.
- 2. Imported birds must be kept in cages, so that they could not come in contact with any other animals.
- 3. Imported pet birds cannot be released in nature.
- 4. Dead birds must be buried deep in the ground.
- 5. After import, rings must be worn on the legs of imported birds within 7(seven) days and inform the licensing authority.
- 6. Importer will have to collect Quarantine Certificate from Livestock Quarantine Station, Hazrat Shahjalal International Airport, Dhaka.
- 7. This NOC is not transferable and import of wild bird is strictly prohibited, except export quotes as per CITES Convention.
- 8. Imported birds must be verified by a forest officer immediate after reach at Hazrat Shahjalal International Airport before leaving the Airport premises.
- 9. This NOC is issued for one consignment only.
