With reference to the above mentioned subject, the undersigned is directed to issue No Objection Certificate (NOC) to M/S. Jishan Trade International, Atra Afilgate, 1/A, Khanjahan Ali, Khulna for importing following Non-CITES cage birds from United Arab Emirate for commercial purpose.

Conditions:

- 1. The above mentioned cage birds will have to import through Hazrat Shahjalal International Airport, Dhaka.
- 2. Imported birds must be kept in cages, so that they could not come in contact with any other animals.
- 3. Imported cage birds cannot be released in nature.
- 4. Dead birds must be buried deep in the ground.
- 5. After import, rings must be worn on the legs of imported birds.
- 6. Importer will have to collect Quarantine Certificate from Livestock Quarantine Station, Hazrat Shahjalal International Airport, Dhaka.
- 7. This Permit is not transferable and import of wild bird is strictly prohibited.

8. Validity period of the permit is up to 22 May, 2021.
