Sub: No Objection Certificate (NOC) for importing Non-CITES Cage birds.

With reference to the above mentioned subject, the undersigned is directed to issue No Objection Certificate (NOC) to M/S. Kashvi Enterprise, 11/A, Main Road-3, Plot-10, Mirpur, Dhaka for importing following Non-CITES cage birds from Togo for commercial purpose.

Conditions:

- 1. The above mentioned cage birds will have to import through Hazrat Shahjalal International Airport, Dhaka.
- 2. Imported birds must be kept in cages, so that they could not come in contact with any other animals.
- 3. Imported cage birds cannot be released in nature.
- 4. Dead birds must be buried deep in the ground.
- 5. After import, rings must be worn on the legs of imported birds within 7(seven) days and inform the licensing authority.
- Importer will have to collect Quarantine Certificate from Livestock Quarantine Station, Hazrat Shahjalal International Airport, Dhaka.
- 7. This Permit is not transferable and import of wild bird is strictly prohibited.
- 8. Imported birds must be verified by a forest officer immediate after reach at Hazrat Shahjalal International Airport before leaving the Airport premises.

9. Validity period of the permit is up to 08 May, 2022.
