- 2. Imported birds must be kept in cages, so that they could not come in contact with any other animals.
- 3. Imported cage birds cannot be released in nature.
- 4. Dead birds must be buried deep in the ground.
- 5. After import, rings must be worn on the legs of imported birds.
- 6. Importer will have to collect Quarantine Certificate from Livestock Quarantine Station, Hazrat Shahjala Linternational Airport, Dhaka.

7. This Permit is not transferable and import of wild bird is strictly prohibited.
