Sub: No Objection Certificate (NOC) for importing Non-CITES Cage birds.

With reference to the above mentioned subject, the undersigned is directed to issue No Objection Certificate (NOC) to M/S. Arpiha Traders, 246/1/C-18, West Agargaon, Sher-e-Bangla nagar, Dhaka for importing following Non-CITES cage birds from South Africa for commercial purpose.

1.	Peach Faced Love Bird	<i>Agapornis roseicollis</i>	300 (Three hundred) heads
2.	Budgerigar	<i>Melopsittacus undulatus</i>	100 (One hundred) heads
3.	Cockatiel	<i>Nymphicus hollandicus</i>	150 (One hundred fifty) heads
4.	Venezuelan Parakeet	<i>Pyrrhura emma</i>	150 (One hundred fifty) heads
5.	Timneh Parrot	<i>Psittacus timneh</i>	50 (Fifty) heads
6.	Ring-Necked Parrot	<i>Psittacula krameri</i>	50 (Fifty) heads
Total:			800 (Eight hundred) heads

Conditions:

1. The above mentioned cage birds will have to import through Hazrat Shahjalal International Airport, Dhaka.
2. Imported birds must be kept in cages, so that they could not come in contact with any other animals.
3. Imported cage birds cannot be released in nature.
4. Dead birds must be buried deep in the ground.
5. After import, rings must be worn on the legs of imported birds.
6. Importer will have to collect Quarantine Certificate from Livestock Quarantine Station, Hazrat Shahjalal International Airport, Dhaka.
7. This Permit is not transferable and import of wild bird is strictly prohibited.
8. Validity period of the permit is up to 19 August, 2021.
