1. The above mentioned plants will have to import through Hazrat Shahjalal International Airport, Dhaka.
2. On arrival of the consignment, it must be examined and will only be released if found to be free from injurious pests, otherwise it may be fumigated or otherwise treated as deemed necessary by the examining Plant Quarantine Officer stationed at Hazrat Shahjalal International Airport, Dhaka or may be returned to the consignor, or may be seized and destroyed following relevant national laws.
3. This Permit is not transferable.
4. Validity period of the NOC is up to 14 March, 2024.
5. This NOC is issued for one consignment only.
