Conditions:

1. The above-mentioned pet-birds will have to be imported through Hazrat Shahjalal International Airport, Dhaka.
2. Imported birds must be kept in cages, so that they cannot come in contact with any other animals.
3. Imported pet birds cannot be released in nature.
4. Dead birds must be buried deep in the ground.
5. After import, rings must be worn on the legs of imported birds within 7(seven) days and inform the licensing authority.
6. Importer will have to collect the Quarantine Certificate from the Livestock Quarantine Station, Hazrat Shahjalal International Airport, Dhaka.
7. This NOC is not transferable and the import of wild birds is strictly prohibited, except export quotes as per the CITES Convention.
8. Imported birds must be verified by a forest officer immediately after reaching Hazrat Shahjalal

International Airport before leaving the Airport premises.

9. This NOC is issued for one consignment only.
