2. Exported birds must be kept in cages, so that they could not come in contact with any other animals.
3. Exported pet birds cannot be released in nature.
4. Dead birds must be buried deep in the ground.
5. Exporter will have to collect Health Certificate of exporting birds from Registered Veterinary Surgeon.
6. This NOC is not transferable and export of wild bird is strictly prohibited.
7. This NOC is issued for one consignment only.
